MISSION ANIME CLUB CONSTITUTION

ARTICLE I: ORGANIZATION SECTION

1. NAME.

The official name of this CLUB is "Mission Anime".

SECTION 2. ALIASES

Aliases include "Anime Club" and "MSJ Anime".

SECTION 3. MISSION STATEMENT.

The goal of the CLUB is to promote, celebrate, and participate in the anime subculture based mainly in Japan.

ARTICLE II: MEETINGS AND EVENTS SECTION

1. SCHEDULE.

MEETINGS will be held twice (2) every week. They will take place in B15 on Tuesdays and in A3 on Thursdays, both occurring during lunchtime.

SECTION 2. CONTENT.

Meeting content includes (but is not limited to) anime showings, art contests, cosplay, lectures, song and dance, and other activities.

SECTION 3. ANNOUNCEMENTS.

An officer, preferably the SECRETARY, will remind the MEMBERS of any EVENTS and/or other activities via email.

SECTION 4. DEFINITION OF QUORUM.

Five (5) MEMBERS are needed to constitute a MEETING.

SECTION 5. EVENTS.

EVENTS include (but are not limited to) anime conventions, cosplay trips, song and dance performances, art workshops, Japantown trips, karaoke, and anime marathon/movie nights.

SECTION 6. MEMBERSHIP.

Only MEMBERS of the CLUB may participate in MEETINGS OR EVENTS.

ARTICLE III: MEMBERSHIP

SECTION 1. DEFINITION

A MEMBER is a student who has registered his or her name, grade, and contact with the CLUB.

SECTION 2. TERM OF MEMBERSHIP

The term of membership is one (1) school year.

SECTION 3. REVOCATION

The OFFICERS reserve the right to nominate any MEMBER for revocation of MEMBERSHIP.

Revocation requires a majority vote from all MEMBERS. The PRESIDENT holds veto power. If vetoed, revocation requires a threefourths majority vote from all MEMBERS.

ARTICLE IV: OFFICERS AND ELECTIONS

SECTION 1. OFFICER TITLES AND DUTIES

The PRESIDENT manages the CLUB, makes decisions, organizes MEETINGS and EVENTS, assigns tasks to OFFICERS, ensures that OFFICERS stay on task, assists OFFICERS, and follows the MISSION STATEMENT. The VICE PRESIDENT takes on the duties of the PRESIDENT when the PRESIDENT is absent, manages public relations, assists OFFICERS, and follows the MISSION STATEMENT.

The SECRETARY maintains minutes, fills out forms (excluding those for the TREASURER), keeps record of MEETINGS and EVENTS, attends the COUNCIL, assists OFFICERS, and follows the MISSION STATEMENT.

The TREASURER manages the club funds, reimburses MEMBERS, turns in club balance forms, keeps records of forms, assists OFFICERS, and follows the MISSION STATEMENT.

The ACTIVITIES COORDINATOR ensures the execution of EVENTS, keeps track of MEMBERS attending EVENTS, assists OFFICERS, and follows the MISSION STATEMENT.

SECTION 2. ELECTIONS

ELECTIONS are held during MEETINGS.

A MEMBER may run for one (1) officer position.

A CANDIDATE must make a speech to the CLUB and answer any questions.

A succeeding OFFICER is elected by popular vote from the other MEMBERS.

The PRESIDENT will break any tie votes.

A succeeding OFFICER begins his or her term the following school year.

SECTION 3. TERM OF OFFICE

The term of office is one (1) school year.

SECTION 5. OFFICER POSITION REVOCATION

The OFFICERS reserve the right to nominate any OFFICER for revocation of officer position.

Revocation requires a majority vote from all MEMBERS. The PRESIDENT holds veto power. If the offending OFFICER is the PRESIDENT, the VICE PRESIDENT holds veto power. If vetoed, revocation requires a three-fourths majority vote from all MEMBERS. SECTION 6. VACANCY OF OFFICE ELECTIONS may be held if there are vacant officer positions.

SECTION 7. REPRESENTATIVE TO COUNCIL

The SECRETARY represents the CLUB at the COUNCIL. If the SECRETARY is unavailable, he or she will assign another MEMBER to represent the CLUB.

ARTICLE V: ADVISORS

SECTION 1. NAME

The name of the ADVISOR is Rachel Tevlin.

SECTION 2. DUTIES

If no other responsible adult is present, the ADVISOR must be present at all MEETINGS. The ADVISOR may supervise the MEETINGS.

ARTICLE VI: FINANCE

SECTION 1. FUNDRAISERS

The OFFICERS may organize fundraisers.

SECTION 2. EXPENDITURES

The TREASURER reimburses MEMBERS who make club expenditures.

ARTICLE VII: AMENDMENTS

SECTION 1. PROPOSITIONS

All MEMBERS may propose AMENDMENTS to the CONSTITUTION.
Ratification requires a majority vote from all MEMBERS. The
PRESIDENT holds veto power. If vetoed, ratification requires
threefourths majority vote from all MEMBERS.
